TENTH AMENDMENT TO DECLARATION
OF CONDOMINIUM PROPERTY REGIME
AND MASTERDEED
OF
DORSEY VILLAGE CONDOMINIUMS

This Tenth Amendment is made and entered into as of December 20, 2006,
by Dorsey Village, LLC a Kentucky limited liability company ("Grantor").

RECITALS

- A. Grantor placed to record a Master Deed and Declaration of Condominium Property Regime of Dorsey Village Condominiums, dated January 25, 2005, of record in Deed Book 8580, Page 441, in the office of the Clerk of Jefferson County, Kentucky (the "Declaration"), which submitted to a horizontal condominium property regime (the "Regime") certain real property described in the Declaration and as Amended in Deed Book 8391, Page 460.
- B. The Site Plan is recorded in the office aforesaid in Plat Book 118, Pages 25 through 26.
- C. Grantor wishes to add Building 4 with ten units to the Master Deed and Declaration of Condominium Property Regime of Dorsey Village Condominiums.

NOW, THEREFORE, pursuant to its powers reserved in paragraph 20 of the Declaration, Grantor hereby amends the Declaration, as follows:


