

EIGHTH AMENDMENT TO DECLARATION  
OF CONDOMINIUM PROPERTY REGIME  
AND MASTERDEED  
OF  
DORSEY VILLAGE CONDOMINIUMS

This Eighth Amendment is made and entered into as of September 12, 2006, by Dorsey Village, LLC a Kentucky limited liability company ("Grantor").

RECITALS

- A Grantor placed to record a Master Deed and Declaration of Condominium Property Regime of Dorsey Village Condominiums, dated January 25, 2005, of record in Deed Book 8580, Page 441, in the office of the Clerk of Jefferson County, Kentucky (the "Declaration"), which submitted to a horizontal condominium property regime (the "Regime") certain real property described in the Declaration and pursuant to the Second Amendment to Masterdeed and Declaration of Property Regime of Dorsey Village Condominiums of Deed Book 8391, Page 460.
- B The Site Plan is recorded in the office aforesaid in Plat Book 117, Pages 40 through 41.
- C Grantor wishes to add Building 3 with eight units to the Master Deed and Declaration of Condominium Property Regime of Dorsey Village Condominiums.

NOW, THEREFORE, pursuant to its powers reserved in paragraph 20 of the Declaration, Grantor hereby amends the Declaration, as follows:




